As we approach the end of 2023, I find myself reflecting on the remarkable journey we have undertaken in the face of a rapidly changing climate and other ongoing climate and sustainability threats. Our commitment to local action has never been more crucial, and throughout the year, ICLEI South Asia's robust network of cities, towns, and regions demonstrated incredible resilience and determination.

We began the year by providing key on-ground technical support to Ahmedabad city, which hosted the U20 Sherpa

Meeting, an engagement group under the Group of 20 forum. The meeting emphasised the role of cities in advancing the global agenda for sustainable development through collaboration.

Our focus on climate action and sustainability led to successful partnerships and advancements in various aspects of our work. From continuing our flagship programmes, working on Green City Action Plans for several cities in Malaysia, conducting extensive studies such as on air quality and the usage of public spaces by children, bolstering renewable energy solutions in Bhutan, nurturing urban forests through the Miyawaki technique, to assisting in the decarbonisation of mobility in cities – we have been at the forefront of driving positive change. Several cities in our network garnered praises and accolades for their work, while we also signed memorandums of understanding with Dhulikhel city in Nepal and the Municipal Association of Bangladesh for supporting them in building capacities and in developing local adaptation plans and disaster risk reduction plans.

Action Plan, developed by ICLEI South Asia, at the UZU Mayoral Summit in the City. we organised and hosted the UrbanShift Asia Forum 2023 in Delhi, which brought together city governments from over 25 countries. In addition to our local efforts, we engaged with key climate actors at the 8th Asia-Pacific Climate Change Adaptation Forum (APAN Forum) in Incheon, South Korea, followed by the 8th Asia Pacific Urban Forum in Suwon, South Korea, and more recently at the 28th UN Climate Change Conference of the Parties (COP28) in Dubai, UAE. Our presence and advocacy underscored the importance of local voices in shaping global climate policies.

As we look ahead to 2024, an ever-changing global landscape makes it clear that our work has become more challenging. The urgency of our mission has never been more apparent, and ICLEI South Asia invites our supporters and partners to continue to work with us in building a world that is inclusive and resilient.
