## Addendum Terms of Reference

- a) In Section 'IX. A. Technical Eligibility Criteria', a new clause, numbered '7' shall be inserted and read as, "Notwithstanding anything given in Section IX. A., if the bidder is unable to provide a certificate of completion for any implemented project, as specified in Section IX. A., then the bidder shall submit details of the said project, inclusive of but not limited to, date of commencement, project cost, date of commissioning (if any), client details, project location, project beneficiaries on their letterhead duly signed and stamped by the authorised signatory and certified by an auditor."
- b) A new section is hereby added and shall be read as follows:

#### **XII. Liability**

ICLEI South Asia reserves the right to reject a bid, without any liability or explanation to the bidder, if the said bid does not meet any condition as specified in the original ToR dated 8 November 2024 and the subsequent Corrigenda dated 18 November 2024 and 22 November 2024 and/or this Addendum dated 22 November.
