### **III. Function**

ICLEI with UN Habitat is assisting BMA in undertaking a comprehensive Transit-Oriented Development (TOD) initiative to optimize land use around existing and proposed mass transit stations, improve last-mile connectivity, promote sustainable urban growth, and enhance urban mobility options. The project will support integrated land use and transport planning, ensuring better accessibility, reduced congestion, and improved quality of life for city residents.

The Transport Planner will play a key role in analyzing, designing, and recommending integrated transport solutions within designated TOD precincts in Bangkok. The position requires expertise in public transport systems, non-motorized transport planning, multimodal integration, travel demand analysis, and policy advisory for sustainable urban mobility. The position will be responsible for tasks including:

#### **Key Responsibilities:**

- Support the development of integrated transport and land-use plans for TOD precincts.
- Analyze existing transport infrastructure, travel patterns, and demand forecasts within project areas.
- Develop multimodal access plans, last-mile connectivity solutions, and non-motorized transport (NMT) improvements.
- Coordinate with BMTA, government agencies, urban designers and land-use planners to ensure transport integration with land use strategies.
- Evaluate options for public transport service optimization, pedestrianization, cycling infrastructure, and public realm improvements.
- Support stakeholder consultations with local communities, transport operators, city agencies, and private developers.
- Contribute to the preparation of technical reports, policy briefs, and presentations for government partners.
- Use transport modeling tools and GIS-based mapping to visualize transport plans and accessibility improvements.
- Provide technical inputs on parking policy, travel demand management (TDM), and mobility-as-a-service (MaaS) concepts where relevant.

#### **Mandatory Qualifications:**

##### **Experience:**

- 4–6 years of relevant experience in urban transport or mobility projects, preferably in Southeast Asian cities.
- Experience in TOD projects, multimodal transport planning, or public transport integration.

##### **Education:**

- Master's degree in Transport Planning, Urban Planning, Civil Engineering, or a related field.

##### **Language:**

- Fluency in Thai and English (Read/Write/Speak) is Mandatory.
